## **TODAYS MARKET OUTLOOK**

Markets to make a somber start of the crucial week on soft global cues

The Indian markets suffered sharp sell-off in the last session on weak global cues and on concern about the demonetization impact on the economy.

Today, the start of the crucial week is likely to remain somber on weak global cues and the traders will first be reacting to the news of GST tax reforms from next April suffering a major setback after a two-day meeting of the centre with state officials ended without the resolution of a deadlock on who would administer the tax.

Jittery investors lacked conviction to build positions ahead of the release of the US monthly jobs data, a referendum in Italy over its constitution, and the Reserve Bank of India's policy review next week.

Finally, the BSE Sensex declined by 329.26 points or 1.24% to 26230.66, while the CNX Nifty dropped 106.10 points or 1.30% to 8,086.80.
