Markets to make a positive start on supportive global cues

The Indian markets despite a slow start managed a positive close in last session as the banking stocks recovered their losses and traders digested the slow growth report of Core sector. Today, the start is likely to be in green tailing the positive global cues.

Though, there will be some cautiousness too, as the prospects of a rollout of the Goods & Services Tax regime from April 1, 2017 appeared to recede further after representatives of States expressed concern about the timeline at a meeting of the GST Council.

On the other hand, sugar stocks gained traction on report from domestic rating agency ICRA that Sugar prices are expected to remain firm in the near term due to tight stock position following 9% decline in production and steady growth in consumption.

Shares of logistics companies edged higher ahead of the GST Council meet. Finally, the BSE Sensex gained 47.79 points or 0.18% to 26643.24, while the CNX Nifty added 12.75 points or 0.16% to 8,192.25.
