TODAYS MARKET OUTLOOK

Markets to make a flat but positive start

The Indian markets traded with traction and ended the last session at their record closing high levels amid reports that GST Council decided to cut tax rates on 29 products and 53 services, in what is seen as the biggest overhaul since the launch of the Goods and Services Tax (GST).

Today, the start is likely to be slightly in green, as traders may take some encouragement with report that overseas investors have put in a whopping Rs 87 billion in the Indian capital markets this month so far on expectation of recovery in corporate earnings and attractive yields.

Some support also came with Vice-President M Venkaiah Naidu's statement that various decisions of the central government, including demonetisation and GST, are likely to have a positive impact in the coming years.

Finally, the BSE Sensex surged 251.29 points or 0.71% to 35,511.58, while the CNX Nifty was up by 77.70 points or 0.72% to 10,894.70.
